AAI announces completion of \$ 6.2 MM private offering of Aegean Earth and Marine Corporation

HOUSTON, March 17, 2008. Access America Investments, LLC (AAI) is pleased to announce the closing of the acquisition of Aegean Earth and Marine, S.A., a privately owned Greek company, by Aegean Earth and Marine Corporation (formerly known as Tiger Growth Corporation), a US reporting company, and the completion of an aggregate private investment of \$ 6.2 MM. The Alternative Public Offering or "APO" and private investment was led by AAI's Access America Fund, LP and is being managed through AAI's National Representative in Athens, Greece. Aegean Earth and Marine Corporation is a Cayman Island domiciled, US reporting company, which was a "shell" company prior to the acquisition. AAI acquired Aegean Earth and Marine Corporation from Nautilus Global Partners ("NGP"), an affiliate of AAI.

Aegean Earth & Marine is currently operating in the fragmented infrastructure construction industry in the Balkans and Eastern Mediterranean with a focus on the acquisition, development and operation of marinas throughout the Greek Isles and Aegean Sea. The company is actively pursuing the acquisition of its first construction and marina assets, which it hopes to complete within the next 90 days and has secured significant equity co-investment from key members of management that are well known in the region and industry.
